




SALE OF TENDER PAPER.

- The tender papers (including Tender Call Notice, Approved Tender Schedule & DTCN) will be available in the official web site <http://www.kendujhar.nic.in> from Dt. 06.04.2023 to 20.04.2023 up to 12.00 Noon and can be downloaded from the website.
- Bidders are requested to submit the bid document along with the deposit of requisite non- refundable fees as mentioned in column- 05 in shape of demand draft of any Nationalised/Schedule Bank in favour of Block Development Officer, Telkoi payable at Telkoi and submit the same along with the bid in a separate envelope.
- The tender paper will be received by registered post/speed post only up to 1.00 PM of date- 20.04.2023. The tenderer must superscribe the name of the work/Name of the Contractor with mobile no on the sealed envelope.
- The tender paper shall be opened by the BDO, Telkoi/his authorised officer in presence of the tenderer or their authorized agents on the schedule date and time as mentioned below.
 - Last date of receipt of Tender Paper: 20.04.2023 till 1.00 PM in working days.
 - Date and time of opening of Tender Paper: 25.04.2023 at 9.00 AM. in the Conference Hall of Block Office Telkoi.
- Documents to be attached :** The Following documents should be furnished with the Tender Papers failing which the tender will be liable to be rejected.
 - Self Attested copy of Contractor Registration Certificate.
 - Self Attested copy of PAN Card and Certificate of GSTIN.
 - Joint Venture consortium agreements are not allowed to participate in tender.
 - The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender papers.

6. The SC/ST bidders willing to avail the benefits allowed by Govt. to ST/SC candidates must furnish the XEROX COPY OF CASTE CERTIFICATE and affidavit.
7. The authority will not be responsible for any postal delay.
8. If the rate quoted by the bidder is more than (14.99% Less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bidder are quoted @ 14.99% less than the estimated cost, the tendered accepting authority will finalize the tender through a transparent lottery system.
9. **Additional Performance Security Deposit :** The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No.-14459/W Date-20.09.2018, Govt. Of Odisha, Works Department.)
