- 5) The tender is scheduled to be opened on **Dt-02-05-2023** at **09.00 A.M.** at Block Conference Hall, O/o the Block Development officer, JODA Keonjhar, 758038 in presence of the tenderers or their authorized representatives.
- 6) Documents to be attached: - The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
 - a) Attested copy of Contractor Registration Certificate.
 - b) Attested copy of PAN card and Certificate and Certificate of GSTIN.
 - c) Attested copy of cast certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
 - d) The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender papers
 - e) “Bid Security Declaration” should be submitted.
 - f) Joint venture consortium agreements are not allowed to participate in tender.
 - g) Shortfall of any required document(s) and Tender Paper is liable for rejection.
- 7) Additional Performance Security Deposit:- The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of amount put to tender before the

- 9) If the rate quoted by bidder is more than (14.99% less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of the rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for practical purpose) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all bidders/ authorized representatives, the concerned Block Development Officer and tender committee will remain present.
