



In adherence to above referred bid identification No the following corrections have been made w.r.t. the DTCN clause 112.(g).The other parts of the DTCN remain unchanged.


112. ELIGIBILITY CRITERIA:

(g) The bidder should have satisfactorily executed at least one or maximum two nos of similar nature of works means construction of Building composite (CIVIL + P.H. + E.I.) works of cost combinedly aggregating 100 (Hundred) % of the estimated cost in Govt., or Govt undertaking organization / private organization (In case private organization the completion certificate with TDS to this effect should be furnished). Experience detailing completed similar nature of works, with Certificates from the concerned Officer not below the rank of Executive Engineer or Equivalent need to be furnished by the bidder as per Schedule D. as per Clause No. 72 (Similar nature of works means construction of buildings inclusive of Electrical installations and P.H. works.)


