Short Quotation Call Notice

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 01 (One) nos. of Non AC/Diesel driven **Mahindra Bolero** vehicle having sitting capacity **not more than seven** including driver, which shall confirm to the Terms and conditions (Annexure-II) for official use in Office of the Executive Officer, Champua NAC, Champua on monthly rent basis:

- 1) The vehicle must be in Road worthy condition, shall not be more than 6 months old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid **Contract Carriage Permit**, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs 10,000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Executive Officer, Champua** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charges is to be maximum upto Rs.31,000/-as per the Finance Deptt. Govt. of Odisha Office Memorandum No.30464/F, Dated 06/09/2019 to be quoted separately in the general bid information (excluding fuel and lubricant).
- 6) The vehicle must achieve fuel efficiency of 10 Kms per litre.
- 7) The details of the make and year of manufacture of the vehicle, registration No., mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of valid should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure-III).
- 8) The Quotation completed in all respect should reach the undersigned on or before **21.06.2023 by 12.00 Noon.** and shall be opened on the same day at **01.00 P.M.** in presence of the bidders or their authorized representatives.
- 9) The application form of quotation/ tender contacting General Bid Information & Terms and conditions for Hiring of Vehicle etc. will be available with **NAC Office, Champua** on payment of Rs 500/- from **24.05.2023 to 21.06.2023** or can be downloaded from Keonjhar District Website www.kendujhar.nic.in from dt. **24.05.2023 to 21.06.2023** In case the application form is downloaded from Govt. website, the applicant shall furnish a **Demand Draft in favour of Executive Officer, Champua NAC, Champua for an amount Rs 500/-** (Rupees five Hundred) only towards the cost of application along with the application.
