1.**Cost of Tender paper:** The Tender specification can be obtained from the office of the Block Development Officer, Jhumpura on payment towards the cost of Tender papers as mentioned above (Non-Refundable) in shape of Bank Draft drawn in favour of Block Development Officer, Jhumpura in any Nationalized Bank having its branch at Keonjhar on any working day from 24.07.2023 to 02.08.2023 for the above work.

2.**Sale of Tender papers:** The Tender documents will be sold from 24.07.2023 to 02.08.2023 at Block office Jhumpura between 11.00 A.M to 1.00 P.M on working days only.

3.**Date of receipt and mode of submission of Tender papers:** The Tenderers must submit the sealed tender papers in complete shape through Registered Post/Speed post only, by directly sending it to the B.D.O, Jhumpura in his official postal address. The last date of receipt of tender paper is 04.08.2023 Up to 4.00 P.M. The undersigned will not be responsible for postal delay if any or non-receipt of the papers in time. The tenders must superscribe the name of the work/project on the sealed envelope.



4. Date of Opening of Tender Paper: The tender paper shall be opened on 07.08.2023 at 11.00 A.M in the presence of the tenderers or their authorized representative having written authorization for the purpose and the tender committee in the conference Hall of Jhumpura Block Office.

5. Documents to be attached: The following document should be furnished with the tender papers failing which the tender will be liable to rejection.

- (a) An Affidavit regarding "Bid Security Declaration"
- (b) Self attested copy of Contractor Registration Certificate.
- (c) Self attested copy of PAN card/Certificate of GSTIN.
- (d) Original money receipt granted by B.D.O, Jhumpura towards cost of tender papers.
- (e) Self attested copy of cast certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
- (f) The bidders must produce an original affidavit in support of the authenticity of documents attached with the tender papers.
- (g) Joint venture consortium agreements are not allowed to participate in tender.

6. Shortfall of any required document(s) and Tender paper is liable for rejection.

7. Additional Performance Security Deposit: The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No.-16659/W Date-20.09.2018, Govt. of Odisha, Works Department.) As per office Memorandum No 6559 Dated 05.06.2021 of works Deptt. Govt. of Odisha modification to APS will be followed as detailed below:

8. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

9. The Block Development Officer, Jhumpura reserve the right to reject any or all the tenders without assigning any Reasons thereof. Other details can be seen in the bidding documents.

10. If the rate quoted by the bidder is more less than (14.99% Less) of the tendered amount, then such a bid shall be rejected, and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for practical purpose) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concerned Block Development Officer and the tender committee will remain present.






