

- 2) The tender document (DTCN & BOQ) duly signed by the Contractors should be accompanied with the self attested photo copy of valid GST Clearance certificate, PAN card, Registration Certificate and requisite EMD in shape of Demand Draft drawn in favour of BDO, GHATAGAON" payable at "Keonjhar" from any Nationalized Bank and NSC/ KVP/ Time Deposit duly pledged.
- 3) The tender document (DTCN & BOQ) should accompanied with requisite tender paper cost in shape of Demand Draft drawn in favour of BDO, GHATAGAON" payable at "Keonjhar" from any Nationalized Bank.
- 4) The Civil Contractor in order to take part in the Composite tender should enter into a sub-contract agreement with eligible Registered Electrical Contractors having valid M.V./ H.T. license (Associate with the sub-contractor) and a copy of such agreement for the work after due registration should be attached with the Tender in original along with the copy of the M.V./ H.T license and this shall also form a part of the tender. If the Civil Contractor is having registration in Electrical works under the same name and style, the question of joint venture does not arise. Non-furnishing of sub-contract agreement with illegible registered electrical contractor having valid MV / HT license the bid will be summarily rejected.


