B) Bids shall be received by this Agency up to **5.00 PM on date 08.08.2023** through Registered Post/ Speed Post only. The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same.

2 The **Bid will be opened on Dt 09.08.2023 at 3.00 P.M.** in the office of the undersigned in the presence of the members of the District Level Tender/ Purchase Committee and the bidders or their authorized representative. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.

3 Bidders are requested to submit the bid documents along with the requisite non-refundable fees as mentioned in **Column No. 8** as in shape of Demand Draft in favour of **Block Development Officer, Sadar, Keonjhar** from any Nationalized scheduled Bank towards cost of tender paper (Which is non-refundable).

4 Earnest Money Deposit @1% Of tender value shall be pledged in favour of **Block Development Officer, Sadar, Keonjhar** corresponding to the respective tender value of work and to be deposited along with the bids.(Mentioned in the **Column No. 8**)

5 **Documents to be attached:** The following documents should be furnished with the Tender Papers failing which the tender will be liable to rejection.

- Cost of Earnest Money Deposit (1% of tender value)
- Self Attested true copy of valid registration certificate
- Self Attested copy of PAN Card
- Self Attested copy of Certificate of GSTIN/GST Clearance Certificate

- l) Joint venture consortium agreements are not allowed to participate in tender
- m) The Bidders have to produce an original affidavit in support of the authenticity of documents attached with tender papers as per para-63 of DTCN.
- n) No relationship Certificate as per Para-42(b) of DTCN.
- o) Cost of Tender Paper
- p) The ST/SC contractor who desires to avail price preference shall have to submit affidavit in support to avail price preference.
- 5 The original bid security along with bid document shall be submitted by registered post or speed post in the office of the undersigned from **Dt 31.07.2023 to 08.08.2023 upto 5.00PM** during office hours on working days failing which the bid will be rejected. The received original bid security & bid cost will be verified & opened at **3.00 PM On Dt. 09.08.2023** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids.
- 6 Other details can be seen in the bidding documents.
- 7 Detailed information as contained in the DTCN shall have to be strictly adhered to, while submitting the tender papers.
- 8 All other detailed clauses/ guidelines can be seen in the bid documents.
- 9 The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit, failing which the tender will be rejected.

**Additional performance Security Deposit:**

The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-14459/W Dated 20-09-2018, Govt of Odisha, Works Department)

As per office Memorandum No 4559 dated 05.04.2021 of works Deptt. Govt. of Odisha Modification to APS will be followed as detailed below:-



- 10 Conditional tender will summarily be rejected.
- 11 If the rate quoted by the bidder is more than (14.99% less) of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.
- 12 The authority reserves the rights to reject any or all the bids without assigning any reason thereof.




