1. Only two numbers of medicine store will be selected for empanelment to supply medicine on retail basis.
2. The Medicine Stores should have a valid license under drugs & cosmetic Act 1940 by the Govt and should have a valid GST number.
3. The Annual Turnover of the firm should be more than 50 lakhs.
4. Stocks of commonly prescribed Medicines of in Dharanidhar Medical College & Hospital, Keonjhar should be made available by the Medicine Store.
5. If any medicine prescribed will not be available in the Medicine Store, it will be the responsibility of the Store to arrange it and supply immediately.
6. It will be the responsibility of the Medicine Stores to supply the Medicines to the store of the Dharanidhar Medical College & Hospital, Keonjhar through their employees immediately on receipt of orders in any form. And empanelled store not able to supply required medicines immediately after receipt of order shall be removed from the panel at any time.
7. The Medicine Store must have computer with internet facility, so that the purchase orders will be sent via e-mail.
8. Medicines for each patient is to be packed separately and computerized bill in triplicate mentioning the purchase price and the sale price of the drug must be attached with the Medicines supplied.
9. Prescribed medicines will be purchased at the rate of maximum discount offered on MRP.
Suppliers quoting the highest percentage of discount on MRP will be selected.
10. The payment will be released subject to availability of funds/allotment as well.
11. No advance payments towards cost of items will be made to the supplier. Payment shall be made on receipt of the stock entry certificate on the body of the bill/invoice from the store.
12. If the price bids become equal, selection will be based on the following preference
 - (i) The generic Medical Store in the campus.
 - (ii) Medicine stores in the campus.
 - (iii) Medicine Stores within 200 meters of the campus.
 - (iv) Medicine Stores beyond 200 meters of the campus.
13. If more than one supplier are empanelled, in such case purchase will be made on monthly rotation basis.
14. In the event of any dispute out of the contract, such dispute should be subject to the Jurisdiction of the Civil Court, Keonjhar. District- Keonjhar only.
