Sub: Notice for submission of explanation on irregular maintenance of day to day Expenditure Register as observed by the Expenditure Observer.

Sir,

It is observed by the Expenditure Observer during his inspection of accounts on 12.04.2019 that you have not maintained your day-to-day Expenditure Register pertaining to Election matters properly and the following irregularities have been observed by the Expenditure Observer.

1. The expenditure shown by you for Rs. 19,070/- are not made from Bank withdrawals from the Bank Account maintained for the purpose.
2. The Bank Pass Book though opened on 02.04.2019 with a balance of Rs. 1,000/- (Rupees one thousand), there was no transaction till the date of Inspection.
3. The supporting vouchers have not been produced in support of the expenditures during Inspection.

Your are, therefore, requested to show cause on the above irregularities and submit your accounts registers with supporting documents for further verification on 17.04.2019 failing which it will be presumed that you have failed to maintain your election expenditure account properly and action as deemed proper shall be taken against you.
