NOTIFICATION

Whereas, taking into consideration of proceedings of the meeting held on 11.05.2023 at 05:00 PM in the Office Chamber of the Executive Officer, Joda, Municipality regarding progress of flyover bridge and diversion of vehicles under the Chairmanship of the Sub-Collector, Champua vide memo No.1416, dated 11.05.2023.

And whereas, the numbers of heavy goods vehicles are plying & parking regularly from **Tata DAV School, Joda** to **Kamarjoda Parking area** the construction work of Joda flyover bridge is seriously affected and will not be completed in time.

Now, therefore, in exercise of powers conferred on me by section 115,116,117 of MV Act.,1998, I Shri Ashish Thakare, Collector & District Magistrate cum-Chairman, Regional Transport Authority, Keonjhar do hereby restrict the movement & parking of HGV, MGV & other mining material carrying vehicles from **Tata DAV School, Joda** to **Kamarjoda Parking area** for a period of one month w.e.f. **20.05.2023** to **20.06.2023** in order to facilitate timely completion of construction work of Joda flyover bridge.
