
NOTIFICATION

Whereas, taking into consideration of proceedings of the District Road Safety Meeting held on 18th January, 2023 & 28th March 2023 at 04:30PM in the Mini Conference Hall of Collectorate, Keonjhar that frequent accidents are occurs in some accident prone areas of Keonjhar district due to illegal parking of heavy goods vehicles.

And whereas, the numbers of heavy goods vehicles are parking illegally at **Dhurpada - Maligaon- Sathigharsahi** over bridge on NH-20, **Indian oil petrol pump, Raisuan to Raisuan over bridge** on NH-20 & **OTDC Guest house, Judia to Judiaghathi turning** on NH-49 frequent accident & traffic problems occurs in those places.

And whereas, the **Dhurpada - Maligaon- Sathigharsahi** over bridge on NH-20, **Indian oil petrol pump, Raisuan to Raisuan over bridge** on NH-20 & **OTDC Guest house, Judia to Judiaghathi turning** on NH-49 shall be declared no parking zone for the heavy goods vehicles and no parking sign boards shall be installed in those areas. After declaration of no parking zone the enforcement activity shall be taken against the violators.

Now, therefore in exercise of powers conferred on me by section 115,116,117 of MV Act.,1998, I Shri Ashish Thakare, District Magistrate and Collector-cum-Chairman, Regional Transport Authority, Keonjhar do hereby declared '**No Parking Zone**' to restrict parking for heavy goods vehicles at **Dhurpada - Maligaon- Sathigharsahi** over bridge on NH-20, **Indian oil petrol pump, Raisuan to Raisuan over bridge** on NH-20 & **OTDC Guest house, Judia to Judiaghathi turning** on NH-49 for greater interest of Keonjhar district w.e.f **01.09.2023 to 30.09.2023**.




