



The agency should be responsible for non- collection of waste on daily basis. He should take proper care for redressal of public grievances on sanitation work. He should take immediate and appropriate step to mitigate the public grievance in a war footing manner.
5. The agency will deploy at least one supervisors at to whom complaint will be lodged by the public so far sanitation is concerned.
