## **NOTIFICATION**

- 1. WHEREAS it has come to the notice of the undersigned that, large numbers of empty and loaded trucks carrying iron ore / minerals to Paradeep and other destinations are used to ply in the Naranpur-Harichandanpur-Brahmanipal PWD road of Keonjhar district.
- 2. WHEREAS the empty and loaded trucks carrying iron ore / minerals are allowed to ply in NH-215 (NH-20) i.e. from Barbil to Ragudi to Paradeep and other destinations.
- 3. WHEREAS the general public to ply with small and medium vehicles for their conveyance to Cuttack-Bhubaneswar, using the Naranpur-Harichandanpur-Brahmanipal Road.
- 4. WHEREAS the widening of Naranpur- Harichandanpur- Brahmanipal Road is under process, plying of heavy loaded vehicles in the Naranpur-Harichandanpur- Brahmanipal Road cause damage to the road.
- 5. NOW, THEREFORE, in exercise of powers conferred on me by Section-115 of Motor vehicle Act'1988, I., Shri Ashish Thakare, IAS, Collector and District Magistrate –cum- Chairman, RTA, Keonjhar, do hereby restrict the movement of Heavy Goods Vehicles except vehicles carrying essential commodities on the Naranpur Harichandanpur Brahmanipal Road State / PWD Road from 20.10.2023 to 19.11.2023.
