The Zilla Parishad, Keonjhar intend to hold a Walk-in-Interview on **dt.05.12.2023 at 11.00 A.M** in the Conference Hall of Zilla Parishad, Keonjhar for reengagement of 22 (Twenty two)nos of retired Government Engineering Personnel(JEs/AEs) as OSDs on contractual basis for One year or till appointment of regular JEs/AEs whichever is earlier for smooth implementation of different developmental works including Mahatma Gandhi NREGS, PMAY-G and other Government flagship programmes. The consolidated monthly remuneration of OSD is Rs.20,000/- per month with additional amount not exceeding Rs.5000/- per month towards conveyance allowance/mobile allowance etc. The interested Retired Government Engineering Personnal(JEs/AEs) are required to submit complete application in the prescribed format duly filled in by the applicant in his/her own hand writing in Bold Capital Letter in Blue/Black Pen along with required documents in an Envelop super scribed "Application for the post of OSD" in the address to CDO-Cum-EO, Zilla Parishad, Collectorate, Keonjhar through **registered post/speed post/by hand** only latest by **dt.29.11.2023 till 5.30 P.M . Reporting time for certificate verification is on 05.12.2023 at 10.00 A.M.** Submission of application in any other mode will be rejected. Incomplete and defective applications shall not be taken into consideration and liable for rejection. The authority will no way responsible for any postal delay. No TA/DA will be provided to the personnel for attending the interview. The re-engagement of Retired Government JEs and AEs shall be pursuant to GA & PG Department Resolution No.23750 dated.27.08.2014 and FD O.M No.24533/F dated.29.09.2022 and subsequent modifications issued from time to time. The engagement of OSDs is subject to fulfillment of following eligibility criteria.

Documents to be furnished along with the application form:-

- 1.Copy of 2 nos passport size photographs(one be affixed in the right corner of application form).
- 2.Proof of Identification(Aadhaar Card/Votor Id card/IT PAN/Driving License).
- 3.Copy of High School Certificate towards proof of age.
- 4.Relieve order towards retirement on attaining the age of superannuation. The final Pension Order if available, a self attested copy of the same may be attached.
- 5.Medical fitness certificate from Authorized Medical Officer not below the rank of Asst. Surgeon.
- 6.Certificate from the Head of Office in which the employee last served to the effect that no departmental proceedings, vigilance case or criminal case are contemplated/pending against the personnel or he has been penalized for misconduct during last five years.(to be submitted in original)
- 7.Copies of self attested Academic Certificates and mark sheets of all technical qualifications

Eligibility Criteria:

- 1.The personnel must be a retired employee of Government of Odisha from the post of Junior Engineer/Assistant Engineer. The Original documents relating to


date of retirement issued by the authority competent along with certificate of academic qualification and identification should be produced at the time of interview.

2.The age of the personnel must be within 65 years having good service records and physically fit. The past service of the personnel should be free from departmental proceeding/vigilance case etc.

3.Submission of false or fabricated information, if found in future, the candidature will be disqualified and will lead to criminal action.


4.One month notice from either side is mandatory to quit/disengage of OSDs.




