1. General Terms & Conditions:

- (i) Notified Area Council, Champua invites sealed quotation in two-quotation (1. Technical Bid & 2. Financial Bid) format from the registered firms / Entrepreneurs / Agency/ Contractors/Private Companies towards supplying, installation and commissioning for “Supplying, fixing and installation of Adiyogi Shiva Statue (H X W X D) 12’.0” X 14’.8” X 7’.0” made of FRP for Open space development work in Champua NAC, for the year 2023-24.” as per specification given in quotation notice.
- (ii) The quotation is meant “**Supplying, installation and commissioning for** “Supplying, fixing and installation of Adiyogi Shiva Statue (H X W X D) 12’.0” X 14’.8” X 7’.0” made of FRP for Open space development work in Champua NAC, for the year 2023-24.”, as specified in the quotation. Champua NAC shall have right to float any comprehensive bid during the contract period and no party will have right to challenge it.
- (iii) Champua NAC shall have the right to terminate the contract on the ground of supply of poor quality material.

Champua NAC shall have right to float any comprehensive bid during the contract period and no party will have right to challenge it.
- (iii) Champua NAC shall have the right to terminate the contact on the ground of supply of poor quality material.

- (vi) At any time prior to the deadline for submission of bids, NAC, Champua may, for any reason at its own initiative modify the quotation document by amendment.
- (vii) The amendment will be published on the office notice board of Champua NAC. In order to afford prospective quotationer(s) reasonable time in which to take the amendment into account in preparing their bid, Champua NAC may, at its discretion extend the deadline for the submission of quotation.
- (viii) Technical bid will be opened on **30.12.2023 at 11.00 A.M.** at Champua NAC office in the presence of the quotationer or their authorized representative, who are present at the scheduled time & financial bids will be opened on the same day. Financial Bids of only those Quotationer will be opened, who qualify in Technical Bid.
- (ix) The Firm/Entrepreneurs/Agency/Contractors/Private Companies should have minimum 2yrs experience in same sector. Copy of work order clearly specifying the date of award contract final project for execution, Contacting authority should be attached.
- (x) In the event of the due date of receipt and opening of the quotation(s) being declared as holiday for the Institute, then due date of receipt / opening of the Quotation will be the next working day at the same time.
- (xi) The quotationer(s) are requested to read the quotation document carefully and ensure compliance with all the instructions herein. Non-compliance of the instructions contained in this document may disqualify the quotationer from the quotationing exercise.
- (xii) Any amendment and / or addition made to the quotation are not permissible after opening of the quotation, incomplete quotation(s), will be rejected.
- (xiii) The successful bidder will give one year warranty on supply items
- (xiv) Champua NAC reserves the right to reject any or all quotation(s), wholly or partly or close the quotation at any stage prior to award of contract without assigning any reason whatsoever.

2. Eligibility Criteria:

1. The Quotationer should have Valid Regn. Certificate/ Dealer Certificate/ Manufacturing license.
2. The Quotationer should have GST Regd. Certificate and up to date GST clearance Certificate.
3. The Quotationer should have Valid PAN
4. The Quotation have Income Tax clearance certificate.
5. Affidavit regarding warranty for one year on supply items.
6. The quotationer has not been debarred and / or blacklisted by any Central Government and / or any State Government Department(s) and / or any PSU and the quotationer should not have any litigation in any of the labour court(s). An undertaking shall be enclosed with the technical bid.
7. The Bidder Must have executed Work in any Urban Department of Odisha for which he has to submit the Work order Copies along with the quotation

8. The Bidder has to submit the valid ES,EPF & Labor License
9. The Annual Turn Over of the Bidder should not less than 1 crore. For the same the bidder has to furnish the ATO/Balance Sheet duly signed by the Chartered Accountant. For the new firm, they have to submit the GSTR Copy/the turn over certificate issued by CA/the work order copies towards the qualification criteria for the ATO.

3. Earnest Money Deposit:

The earnest money deposit of the quotationer, whose quotation has been accepted, will be returned after successful completion of the contract period. Earnest money deposit of the successful quotationer shall be forfeited, if one refuses or neglects to execute the contract or fails to supply the required materials within the time frame as specified by Champua NAC. After the award of the contract to successful quotationer, the earnest money deposit of all other quotationer(s) will be refunded within 30 day whose offers have not been accepted.

4. Evaluation:

4.1 Technical Bid:

- (a) The Technical bid will be in the format enclosed with quotation as **Appendix - A** in separate sealed cover. All the self-attested supporting documents should be attached with the Technical bid.

4.2 Financial Bid:

- (a) The financial bid will be in the format enclosed with quotation as **Appendix - B** in separate sealed cover. Failure to provide price bid in a sealed separate cover will result in invalidation of the offer.

(b) Offers in the financial bid should be written in English and price should be written in both figures and words. Where ever, if there is difference between the rate quoted in figures and words, the rate quoted in word will be taken as correct. The offer should be typed or written in pen ink or ball pen. Use of pencil will be ignored. Bids containing over writing/ additions/obliteration & and other discrepancies should be properly attested by them.

(c) The quoted rate should be inclusive of all taxes & transportation charges but excluding GST.

(d) The financial bids shall be opened for those bidders who qualify after the evaluation of Technical bid. It shall be evaluated on the basis of lowest rate quoted by quotationer(s). The bidder who has quoted lowest rate will be selected.

5. **Award of Contract:** After due evaluation of the financial bids, Champua NAC will award the contract to the lowest quotationer (hereinafter referred to as the "Contractor").

6. Technical Specification for ALL FRP Sculptures will be as under:-

1. It should be all weather proof, robust to all weather condition.
2. Statue should be 12' feet height, 14.8' feet width, 7' feet. depth and weight of statue should be 400 Kg.
3. Thickness of fiber 4 to 5 mm (supported by g.i. 1" pipe + iron rods & g.i pipe to maintain stability & long lasting quality)

4. Fiber material (poly resin unsaturated polyester resin-isophthalic resin (iso resin), fiberglass chopped strand mat 450 gsm, cobalt, catalyst. minimum 3 coating of Fibre & mat required to be applied) and use of fibre material weight should be 250 Kg.
5. Colour metallic bronze, brass, golden, black stone look, and multi colour finishing with lacquer and deco colour. all weather proof, long lasting for indoor as well as outdoor environment. the statue should be painted with special colours which sustain long in direct sun lights. it should be uv rays protected.
6. Statue should be reinforced with all necessary m/s steel rods, gi pipes as and where required.
7. Installation and commissioning to be included
8. Transportation & installation at site in CHAMPUA NAC LIMIT to be included in Quoted Price
