NOTICE INVITING TENDER (e-Procurement)

1. Block Development Officer, Champua Block, Keonjhar on behalf of Governor of Odisha invites bids through e-procurement in Single cover and double cover system separately for the projects as per Annexure-I to this Bid Notice. The bid should be submitted online in the website www.tendersorissa.gov.in by eligible Contractors with CDMS registration. The bidders should have necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government within a month of acceptance of bid.
2. The bidders may submit bids for the following works (Annexure-I):

4. Bids received online shall be opened on 17.08.2024 at 11 AM in the conference hall of office of the Champua Block, Champua, Keonjhar in presence of the bidders or their authorized representatives who wish to attend.

Bidders who participated in the bid can witness the date of opening of the bids after logging on to the site through their DSC. If the office happens to be closed on the day of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

5. The amount put to tender is exclusive of GST. The intending bidder should offer their rates excluding GST as applicable on works contract. The GST shall be paid over the work bill amount at the time of payment of each bill.
6. The requisite **EMD** of the individual project in shape of Demand Draft drawn in favour of Block Development Officer, Champua payable at "Champua" from any Nationalized Bank having its branch at Champua and NSC/ KVP/ Time Deposit duly pledged.
7. The requisite **tender paper cost** (Non-Refundable) as mentioned in Col-7 of Annexure-I in shape of Bank Draft drawn in favour of BDO, CHAMPUA payable at "Champua" from any Nationalized Bank having its branch at Champua.
8. Bids must be accompanied by a non-refundable fee as indicated at Column-7 of Annexure towards cost of bid documents and the amount specified at Column-5 as bid security of the individual project mentioned in Annexure-I to this bid notice payable in favour of Block Development Officer, Champua Block, Keonjhar.
9. Other details can be seen from the Bidding documents which is available in the Website www.tendersorissa.gov.in.
10. Engineer contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed EMD Exemption for three nos. of works during this financial year and to show the original CDMS Registration Certificate to the tender Opening Authority for verification without which the tender will be rejected. A bidder has to deposit 1% EMD/Bid Security of the amount put to tender rounded off to the nearest one hundred rupees, if he/she proposes to **engage machineries and equipment** as asked for in the tender documents, owned or hired but **deployed from outside the state**.
11. Tender shall be uploaded in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The on-line bidders should upload the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including bid security accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuinely of the documents should be uploaded. **The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuinely of signature put on other uploaded documents including affidavit and lease deeds is beyond preview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law. The bidder is required to submit original affidavit against each project.**
12. **As per Office Memorandum No. 14299 / Dtd. 03.10.2017 of Works Department, Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in accordance with latest circular of works Department 4559 / dt. 05.04.2021 indicated as Sl. No. 6 & 7 in shape of Demand Draft / Term Deposit Receipt pledge in favour of the Block Development Officer, Champua , Keonjhar within seven days from the date of opening, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. Following all codal procedure from time to time as laid down.**
13. Additional Performance Security shall be submitted by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish an amount as

stipulated below towards Additional Performance Security (APS) within seven days of issue of Letter of Acceptance (LoA) by Block Development Officer, Champua , Keonjhar.

It should be in shape of Term Deposit Receipt (TDR) pledged in favour of Block Development Officer, Champua payable at Keonjhar. The successful bidder may also submit APS in shape of Bank Guarantee issued in favour of Block Development Officer, Champua from any nationalized bank located at Champua.

14. Bidders are advised to note the minimum qualification criteria specified in Clause-10 of the instruction to bidders to qualify for the award of the contract. Interested bidders may obtain clarifications regarding the minimum qualification criteria from the office of the Block Development Officer, Champua ,Keonjhar prior to participation in the bid.

15. Bid documents consisting of qualifying information and eligibility of the bidders, plans, specification, drawings, the schedule of quantities of estimate and abstract of various classes of work is available in the Website www.tendersorissa.gov.in.

16. Bid for the work shall remain open for acceptance for a period of Ninety (90) days from the last date of receipt of Bids. If any Bidder/ Tenderer withdraw his/her Bid /tender before the said period or makes any modifications in the terms and conditions of the Bid, the said earnest money shall stand forfeited. Conditional Bid in any manner is subject to forfeiture of EMD.

17. No Engineer of Gazetted Rank or other Gazetted Officer employ in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for a period of two years after his retirement from Government Service without Government permission.

18. Clear scanned copies of **No relation certificate in shape of affidavit, original valid Contractor Data Management System (CDMS) Registration Certificate, valid & active GST Certificate, PAN, Affidavit** regarding correctness/authenticity of document(s) for each work separately, Affidavits for claiming / availing of price preference in case of SC/ ST / Physically Handicapped Contractors should be clearly indicate and mention the e-mail ID & contact No. also should be uploaded along with the Bid documents for any such immediate contact and smooth facilitation in communication facility to the concerned bidder. **Non-visible copies of documents may be liable for rejection of BID.**

19. As per **Codal Provision, works more than Rs 50.00 lakhs should be in Double cover mode** i.e. Cover-I contains (Technical Bid) & Cover-II contains (Financial Bid) to be filled up separately indicating therein as "Cover-I and Cover-II" respectively and finally put together in one Cover. After due scrutiny, the Cover-II will be opened. **Work experience Certificate for the last 03 years to be produced (minimum up to Rs.40.00 lakhs).** In case of bidders having no Experience Certificate, the tender will be rejected.

20. The participating bidders must submit all uploaded documents in hard copy self-signed in each page and original Demand Draft for cost of Bid Documents (Non-Refundable) and EMD in a sealed cover on or before dt.13.08.2024 till 5.00 p.m. and addressed to the Block Development officer, At/P.O.-Champua , Dist.-Keonjhar, PIN-758041 through Registered/Speed Post only failing which participation of the bidder will not be entertained and the bid will be rejected. The bidders must superscribe the Sl. No. and Name of the work/project on the sealed envelope.

21. **The bidder must produce original documents for verification at the time of opening of tender.**
22. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Junior Engineer or above is related to him.
23. The bidder quoting more than 14.99% less (decimals up to two numbers will be taken for all practical purpose) rate such bid will be rejected.
24. Further corrigendum if any can be seen from the website: www.tendersorissa.gov.in / office Notice Board.
25. GST to be imposed as applicable.
26. The bid is liable to be rejected if the TDRs submitted found fake and criminal action shall be initiated against the bidder.
27. In case of transparent lottery need to be conducted in accordance with the Works Department Order No.12366 dtd 08.11.2013 and 1437, dated 31.01.2023, the lottery will be held in a suitable date and venue which will be intimated to the bidders concerned. The date of lottery will be intimated to bidders through Contact No./WhatsApp/email. If any deviation in this due to some unavoidable / unwarrent circumstances, will be intimated as per given contact no./ mail ID / through office Notice Board for bidder information and the remaining process will be taken care in the next working day or any suitable date as fixed and the same time and venue will be intimated.
28. Successful tenderer will be intimated for executing Agreement timely with due instructions and S.O.P. followed by Govt. time to time. It is binding on successful bidder to extend all necessary support in getting the quality control tests required till completion of the work in all respect at his own cost.
29. Authority reserves the rights to reject any or all the tenders without assigning any reason thereof.
30. Any changes regarding Bid security declaration from finance department Govt. of Odisha will be followed.
31. The bidders should must be furnished the work programme at the time of execute the agreement.




