2. The above appointment (s) is purely temporary and terminable at any time without assigning any reasons thereof. The candidates are required to join at the place(s) of their posting within 15 (fifteen) days from the date of issue of this order, failing which the appointment order will stand cancelled automatically. Suppression of correct information or furnishing of false information shall render the applicant liable for removal from service as well as penal action under the provisions of existing laws against him/her.

3. The appointees will be on probation for a period of two years from the date of their joining as Panchayat Executive Officer.

4. Their G.P.F. and pension shall be regulated as per "The New Restructured Defined Contribution Pension Scheme-2005" issued by the Govt. in Finance Department Memorandum No.44451/F dated 17.09.2005,30132/F dated 13.07.2006 & 10327/F dated 21.03.2012 and subsequent instructions issued from time to time.

 - ii) Character Certificates from two Gazetted Officers (Group – A or Group – B).
 - iii) Attestation form of Character and antecedent verification duly filled in along with photograph as in item (i) above.
 - iv) Medical fitness certificate from one authorized Medical Officer not below the rank of Asst. Surgeon.
 - v) Certificate to the effect that they are married or unmarried. If married, they should not have more than one spouse living.
 - vi) Oath of allegiance to the constitution of India duly filled in.
 - vii) Property statement in prescribed form duly filled in and submitted in sealed cover.
 - viii) Copy of self attested Educational Certificate(s), Residential Certificate, Caste Certificate etc issued by the competent authority.


