5. Experience of preparation & supply of display board in at least 5 districts in Odisha during last 5 (five) consecutive years under the Department of Agriculture Farmers Empowerment Govt of Odisha (order copy of DDA/CDAO to be attached)
6. IT Return of last 3 (three) consecutive years
7. GST Certificate of the agency.
