

TENDER CALL NOTICE

Sealed Tenders are invited from the intending registered transport contractors/Agent having valid agent license for engagement of transporting agent under Mid-Day-Meal programme for transporting of rice from FCI point to school point in Keonjhar district within maximum ceiling price of Rs.150/- (Rupees One Hundred Fifty) only per quintal, as fixed by Govt. for the year 2024-25. The tenderer shall apply for of the district as a whole. The tender paper for the above purposes containing the terms and conditions, cost of tender paper, E.M.D and statutory requirement can be downloaded from the Dist. Website i.e. www.keonjhar.odisha.gov.in or available at DPMU (MDM), C/O District Education Officer, Keonjhar. The tender paper complete in all respect should reach the office of the District Project Management Unit (DPMU), MDM, Keonjhar by **2.00 P.M** of **18.09.2024** through **registered post/speed post** only and the sealed tenders will be opened **18.09.2024** at **3.00 PM** in the mini conference hall of collectorate, Keonjhar in presence of the members of the tender committee and the tenderers or his/her authorized representative. The tender received beyond the date and time mentioned above shall not be taken in to the consideration. The Collector, Keonjhar reserves the right to reject/cancel/withdraw any or all the tenders without assigning any reason thereof and shall bear no liability what so ever consequent upon such decision.

APPOINTMENT OF TRANSPORTING AGENT UNDER MDM IN KEONJHAR DISTRICT FOR THE YEAR 2024-25

Sealed tenders in the prescribed form are invited from the intending registered transport contractors/Agents having valid license to engage for transportation of rice under MDM from FCI /PEG / RRCs point to school point in Keonjhar District within the maximum ceiling price of Rs.150/-(Rupees One Hundred Fifty) only per Qntl. irrespective of Kms/distance during the year 2024-25 as per the prescribed terms and conditions.

The sealed tender(s) shall be received by the DPMU(PM POSHAN)C/O District Education Officer, Keonjhar on behalf of the Collector Keonjhar by Regd.post/Speed post till **2.00 pm** on dt.**18.09.2024** and will be opened on **18.09.2024** at **3.00 PM** in the mini conference hall of Collectorate ,Keonjhar in presence of the members of the tender committee and the tenderer or his/her authorized representative by producing the letter of authorization. The tender received beyond the date and time shall be liable for rejection.

The tender papers should be submitted in sealed cover superscribing in block capital letter such as **"TENDER FOR UNDERTAKING TRANSPORTATION WORK UNDERMDM(PM POSHAN) IN KEONJHAR DISTRICT DURING 2024-25"**.

The detailed tender paper along with the prescribed tender schedule can be downloaded from the district website i.e.www.kendujhar.odisha.gov.in and original bank draft amounting to Rs.15000/- (Rupees fifteen thousand) only towards cost of tender paper to be drawn in favour of **District Education Officer, DPMU, MDM(PM POSHAN) Keonjhar**, payable at Keonjhar should be enclosed towards cost of tender paper which is non-refundable. The tender without this demand draft will be summarily rejected. The detailed tender paper should be submitted with the tender duly signed by the tenderer as token of acceptance of the terms and conditions. All the tender papers/documents must be attested by the competent authority are to be submitted by the tenderer.

TERMS AND CONDITIONS OF THE TENDER

1. The tenderer shall be carefully go through all the terms and conditions of the tender documents and submit the tender papers correctly and in complete form. The tender paper should be filled in properly and legibly without any correction/overwriting and must be a typed copy/computer typed copy. No opportunity shall be given to the tenderers to rectify or amend any defect detected at the time of scrutiny. The rates should be written both in words and figures in the tender paper. The rate quoted should be final and tenderer shall not be allowed to change the same under any circumstance and it should be valid for theyear**2024-25**.
2. No individual company, firm, corporation shall participate in the tender process unless it obtains or possess valid agents license under O.M.V (Licensing agents). under the carriage by Road Act,2007 with the Carriage by Road Rules, 2011.
3. The successful tenderer shall be required to lift rice from FCI/PEG/OSWC/RRCs depot Keonjhar and transport the same to school point of the Keonjhar district as per the order of the Collector, Keonjhar within the specified period after lifting of the rice from FCI/PEG/OSWC/RRCs depot. The rice will be delivered at the school points on the same day.
4. It is the responsibility of the transporting agent to lift the rice from FCI/PEG/OSWC/RRCs depot Keonjhar and deliver the same at the school point of Keonjhar district on proper weighment. The weighing machine shall be taken by the transporting agent along with the vehicle. The transport agent will be held responsible for the shortage and damage, if any noticed during transit and delivery. The quality and quantity of the food stuff being transported may be inspected by the Govt. official authorized by collector during transit and also at the delivery points. There shall not be any change both in quality and quantity of the food grains during transportation by the transporting agent and for any short coming at this front the transporting agent shall be held responsible and this shall be treated as misappropriation by the transporting agent. **If any misappropriation is noticed during inspection or otherwise, penalty shall be imposed which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.**

5. The tenderer shall submit the following documents along with the tender paper. In absence of any documents/papers the tender form will be liable for rejection by the competent authority. The tenderer shall have to produce the original documents if necessary before the tender committee for verification.
6. Original tender paper duly signed (each page) by the tenderer as token of acceptance of the terms and conditions of the tender. On scrutiny during technical bid, if it is detected that any paper is unsigned by the tenderer, the application is liable for rejection.
7. Original bank draft amounting to Rs.15000/- (Rupees fifteen thousand) only towards tender application cost drawn in favour of **District Education Officer, DPMU, PM-POSHAN (MDM) Keonjhar.**
8. Attested copy of the valid agent license owned by the tenderer under Odisha motor vehicle (Licensing of Agents) under the carriage by Road Act, 2007 with the Carriage by Road Rules, 2011.
9. Attested copy of update valid Income Tax Return Certificate for Assessment year 2022-23 & 2023-24, Pan Card & GST Registration Certificate from the competent authority along with updated GST status must be furnished along with the tender paper.
10. Transport license under Odisha Motor Vehicle under the carriage by Road Act, 2007 with the Carriage by Road Rules, 2011.
11. Labour license from the competent authority.
12. Authority should be furnished along with the tender paper failing which the tender will be liable for rejection.
13. Certificate from any Govt. organization about past experience of the tenderer in transportation of rice or any food materials. The accepting authority shall have the right not to accept tender(s) from contractors who have not performed satisfactorily in preceding years under this programme.

14. **Earnest money Deposit(EMD) of Rs.25, 00,000/- (Rupees Twenty Five Lakh)** only for transportation for whole district in shape of demand draft/term deposit receipt/FDR duly pledged in favour of **District Education Officer, DPMU, PM-POSHAN (MDM)Keonjhar** shall be furnished along with tenders. Tenders without earnest money will be liable for rejection. Cash/Cheque shall not be accepted. No request for transfer or any previous deposit or adjustment or earnest money deposit for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejection of the tender paper. No tender shall be allowed to withdraw his tender / earnest money deposit until the tender is finalized. In case, the successful tenderer refuses to be the transporter after acceptance of his tender, the earnest money deposit by him will be liable for forfeiture. The E.M.D of the unsuccessful tenderer shall be refunded after finalization of the tender whereas the E.M.D of the successful tenderer will be kept as security deposit and will be released after successful completion of contract period, settlement of payment thereof and audit of such account and after obtaining the audit report. The collector will not be liable for payment of any interest on the security deposit or any depreciation thereof. The breach of any terms and conditions as per agreement and failure / unwillingness to undertake transportation work by the selected tenderers within the time limit after acceptance of his tender may lead to forfeiture of E.M.D . The selected transporting agent will be blacklisted for any other Govt. tender, if he fails to perform the duties as per agreement in timely, regular supply of food grains on proper weightment.
15. List of trucks/mini trucks owned / leased (Tipper & Dumper not allowed) by the tenderer with up to date documents (Xerox copy duly attested by the tenderer/ Clearance Certificate copy through online) shall be furnished along with the tender (the tenderer should have minimum five trucks/mini trucks for transportation for whole district) .

16. The tenderer will file an affidavit executed before either the executive magistrate or before the notary in support of that he/she has not criminal background.
17. The tenderer should not be a rice miller and should not have been involved in any PDS related activities. An affidavit to this effect shown before the Executive Magistrate/ the Notary along with non-involvement and non-pendency of any criminal offences, non-involvement in political parties/issues and also about non-Govt. dues pending against him/her must be enclosed with the tender paper. He should not hold any office of profit or be a PRI representative.
18. Telegraphic or conditional tender shall not be accepted.
19. The tenderer should produce Balance Sheet of Audit Report of last one year i.e 2022-23 or 2023-24 if audit completed and audited P&L account for the same year with minimum average turnover of **Rs.50.00 lakhs per annum**.
20. Maximum ceiling price for transportation is Rs.150/- per Qntl. irrespective of distance including all incidental charges.
21. The tenderer has to submit TDR/FDR/FDA (in original) worth **Rs.50.00 Lakh** only pledged in favour of **District Education Officer, DPMU, PM-POSHAN (MDM)Keonjhar** against recent solvency status. This will be refunded after successful completion of contract period and audit of accounts of Transporting Agent if selected. The whole or part of the security will be forfeited for irregular performance or breach of any terms and conditions of agreement during the period of the contact remain force.
22. The successful tenderer shall have to enter into an agreement with Collector, Keonjhar as per the terms and conditions mentioned in the specified agreement format within seven days of intimation acceptance of his tender.
23. The successful tenderer is required to furnish a **minimum Bank Guarantee for Rs. 50,00,000 /- (Rupees Fifty lakhs) only** for the period of contract from the date of signing the agreement.

24. Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of the stock to whom it concerned and as per the approved rate incorporated in the agreement. The D.E.O cum-Dist. Nodal officer MDM(PM POSHAN) ,Keonjhar shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under transportation charges head under MDM and no advance payment will be made.
25. Good conduct and previous fair practice without any misappropriation case shall be an implied condition for selection and this would be verified during scrutiny by the tender committee.If any misleading information detected in this regard,the EMD/TDR/FDR/FDA amount of successful tenderer pledged in favour of District Nodal Officer,MDM(PM POSHAN)Keonjhar shall be forfeited.
26. The Collector, Keonjhar may terminate the contract for violation of terms and conditions of agreement as well as any change of policy in the Govt. or for any reasons to be recorded in writing.
27. In case of violation of conditions of tender the agent will be booked under IPC, essential commodities act. Prevention of food adulteration act and prevention of black Marketing Act.
28. The right of acceptance of tender rests with collector, Keonjhar.It is not binding on tender committee to accept the lowest tender and the Collector also reserves the rights to cancel or reject any or all the tenders without assigning any reason thereof. In case of any dispute the orders / decision of the collector, Keonjhar will be final and binding.The Tender Committee will judge the feasible rate of transportation to award the tender. It is not that tender will be awarded to the tenderer who quotes the lowest rate, if the rate is not feasible.

29. The Transporting Agent will give 04 copies acknowledgement receipt of Mid Day meal Rice delivered to the concerned Schools and received his personal copy only from the Head master of concerned School. In no circumstances the transporting Agent will collect the acknowledgement receipt copy of Mid-Day-Meal Rice of DEO & District Nodal Officer, MDM after delivery at School Point from the concerned Head Master.
30. The transporting agent should not store rice in their own go-downs after lifting from FCI/PEG/OSWC/RRCs Depots and distribute the rice directly to School point and any deviation will be finally dealt with as per rules.
31. No Advance payments of transportation bill shall be allowed.
32. Payment of bill shall be subject to availability of funds.
33. The work is to be carried out with the due diligence and accordance with instruction to be issued from time to time by the Collector/ District Education Officer, Keonjhar
34. The Transport Agent should supply the best average quality of rice to the schools under MDM programme and it should confirm minimum FAQ standard which is received by him from FCI/PEG/OSWC/RRCs Depots. Under no circumstances the Transport agent shall supply rice to school below FAQ standard.
35. Sealed tender in prescribed forms are invited from the intending registered firms/authorized licensing transporting contractor/agent having at least 05no's of transport vehicles in their own name/name of the firm for undertaking transportation of food stuffs under Mid-Day-Meal programme in Keonjhar District from FCI/PEG/OWSC/RRCs point to direct different School Points of different blocks for the year 2024-25.
36. If the transporting agent fails to transport the food stuff within the time limit, the District Education Officer, Keonjhar will take immediate steps to transport the same by other means and the extra cost incurred will be recovered from the pending bills/ Bank Guarantee of the transporting agent.
37. Tender received without required documents shall not be considered and liable to be rejected at the initial stage itself.

38. The District Education Officer, Keonjhar or his representative shall remain present at the time of lifting of rice from FCI/PEG/OSWC/RRCs go-down.
39. The transporting agent shall obtain the requirement of each school from the concerned Block Education Officer / Addl. Block Education Officer-in charge of MDM of the block and distribute rice to the school accordingly.
