1. The Quotation should be submitted along with following documents falling which their application will be rejected:
 - a. Attested copy of valid Registration Certificate and up-to-date clearance of Income Tax.

 - c. Attested copy of GST registration certificate and work experience certificate. The rate should be quoted including all taxes and transporting charges.

The EMD for ₹ 10,000/- (Rupees Ten Thousand) only in shape of Account Payee Bank Draft of any nationalized bank should be deposited along with quotation paper in favour of CDPO, Joda (Urban) and the same will be refunded only after complete of wall painting works. In case of unsuccessful quotationers, the EMD will be returned after finalization of quotation process. Any participating firm, if selected but denied to complete wall painting work its fixed deposit will not return back.
