NOTIFICATION

1. WHEREAS it has come to the notice of the undersigned that, large numbers of empty and loaded trucks carrying iron ore / minerals to Paradeep and other destinations are used to ply in the Naranpur-Harichandanpur-Brahmanipal Road (NH-720) of Keonjhar district.
2. WHEREAS the empty and loaded trucks carrying iron ore / minerals are allowed to ply in NH-215 (NH-20) i.e. from Barbil to Ragudi to Paradeep and other destinations.
3. WHEREAS the general public to ply with small and medium vehicles for their conveyance to Cuttack-Bhubaneswar, using the Naranpur-Harichandanpur-Brahmanipal Road .
4. WHEREAS the widening of Naranpur- Harichandanpur- Brahmanipal Road is under process, plying of heavy loaded vehicles in the Naranpur- Harichandanpur- Brahmanipal Road cause damage to the road.
5. NOW, THEREFORE, in exercise of powers conferred on me by Section-115 of Motor vehicle Act'1988 , I , Shri Vishal Singh, IAS, Collector and District Magistrate -cum- Chairman, RTA, Keonjhar , do hereby restrict the movement of Heavy Goods Vehicles except vehicles carrying essential commodities on the Naranpur - Harichandanpur - Brahmanipal Road (NH-720) from 20.02.2025 to 19.03.2025.


