2. No Quotation will be entertained after the stipulated date and time.
3. The Quotationers have to quote single rate of paintings and the price quoted must be inclusive of all taxes, transporting cost and other incidental charges if any. The rate quoted should be final and the quotation shall not be allowed to change the same in any circumstances.
4. The Quotationers shall deposit all the Security Money amounting to Rs.10,000/- (rupees ten thousand) only in the office of the undersigned and attach the original Money Receipt with the Quotation. The security Money of unsuccessful Quotationers will be refunded after finalization of the Tender Process on proper application. The Security Money of the successful Quotationers will be refunded after completion of paintings works.
5. The Quotation once submitted will not be returned back or exchanged.
6. The Quotationers are required to produce the samples before the Tender Committee for finalization of quotations on dt. 29.04.2025 at 10.30 A.M in the office chamber of the Sub-Collector, Keonjhar and handed over the same to the C.D.P.O Patna for security.
7. The successful Quotationers shall complete painting works within 15 days from the date of receipt of the order, failing which the order will be cancelled and simultaneously the security Money will be forfeited .
8. Any Firm black listed by Central/State Government/Board/ Corporation/ Autonomous body under Administrative control of central/ State Government etc. will not be entertained by the Tender Committee.
9. Payment will be made by the C.D.P.O., Patna after completion of paintings works and receiving certificate from A.W.W and L.S. concerned.
10. Non fulfillment of the aforesaid terms and conditions will lead to non acceptance of quotation.
11. The approved Quotationer is required to submit the copy of First Page of Bank Account Pass Book along with cancelled cheque for easy transaction of payment for the painting works done by the approved quotationers.
