SECTION-I

Instruction to Bidders

A. General Information:

1. Sericulture zone under **Asst. Director of Sericulture, Keonjhar** requires Grainage and Rearing equipment for ERI and TASAR sector.
2. Some of the items intended to be purchased are exclusively meant for Sericulture. So, the bidders should have bear some knowledge on Sericulture or related activities.

B. Eligibility Criteria

C. Submission of Bid:

The proposal complete in all respect as specified must be accompanied with a non-refundable amount of **Rs. 1000/-** towards Bid Processing Fee and EMD of **Rs. 17,030/-** (2% of the estimated cost) in form of Demand Draft in favour of **the Asst. Director of Sericulture, Keonjhar** drawn in any scheduled commercial bank and payable at Keonjhar. The bid should be sent through Speed Post/Registered Post/Courier so as to reach the authority by **5.00 PM on 23.06.2025**.

The authority will not be responsible for any postal delay. Bids without bid processing fee and EMD shall be rejected. Bids submitted after due date will be summarily rejected. EMD of unsuccessful bidders will be returned without interest after the award of Contract.

The bid has been invited under two bid systems i.e. Technical Bid and Financial Bid. The bidders are advised to submit two separate envelopes super scribing "**Technical Bid**" and "**Financial Bid**". Both sealed envelopes must be kept in a third sealed envelope super-scribing "**Bid Document for REARING AND GRAINAGE EQUIPMENT FOR ERI & TASAR SECTOR**".

D. List of Documents for submission:

Bidders are required to furnish the following documents along with the Technical Bid:

- b) Demand Draft in support of Bid processing fee as applicable.

- d) Copy of Certificate of Incorporation of the Firm /agency

- j) Undertaking regarding non-blacklisting (On stamp paper)
- k) Undertaking regarding non-pending of any judicial proceedings (On stamp paper)

Any deviation from the prescribed procedures /required information/formats/conditions shall result in out-right of the bid. Any conditional bid shall be out rightly rejected.

All entries along with the pages in the bid document should be legible, filled in clearly and signed by the authorized representative. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory should be attached.

The Technical Bid will be opened on dated. **24.06.2025 at 11.00 A.M.** in presence of the authorized representative of the bidder who wish to be present on the spot at that time. Financial bid of the Technically qualified bidders shall be opened on dated. **24.06.2025 at 3.00 PM** in presence of the authorized representatives.

The EMD shall be forfeited if the successful bidder fails to undertake the work or fails to comply with any of the terms and conditions of the bid.

To assist in the analysis, evaluation and computation of bids, the authority may ask the bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.

The bidder having the lowest evaluated financial bid and with quality product(L-1) would be considered for award of the contract subject to fulfillment of the terms and conditions of the bid documents. In case the lowest bidder (L-1) is disqualified after selection for any reason, then negotiations will be made with the second lowest (L-2) bidder for award of contract at L-1 price. The quality of the product along with price will be taken in to consideration. However, the decision of the Committee and authority shall be final during the overall selection process.

The authority reserves the right to reject any or all bids and terminate the tender process without assigning any reason thereof.
