4. ii) Only the successful Bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish as per Office Memorandum - 4559/W dt. 05.04.2021 of Works Department as Additional Performance Security in shape of Term Deposit Receipt pledged in favour of the Divisional Forest Officer, Keonjhar Division, Keonjhar / Bank Guarantee in favour of the Divisional Forest Officer, Keonjhar Division from any nationalised schedule bank in India counter guaranteed by its local branch within seven days, otherwise the bid shall be cancelled and further proceeding for blacklisting shall be initiated against bidder.

5. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 Hours of 02.06.2025 to 17.00 Hours of 11.06.2025.

6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.

7. Bids shall be received only "On-line" on or before 17.00 Hours of 11.06.2025.

Bids received on line shall be opened at 10.00 Hours on 12.06.2025 in the office of the Divisional Forest Officer, Keonjhar Division, Keonjhar, Odisha in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

9. The bidder shall transfer online the cost of bid document as shown in column No. 5 above against each work through a process as mentioned under DTCN.
