In pursuance to the letter No. 2683/R&DM (DM) dt. 02.06.2025 of Additional Special Relief Commissioner, Odisha, Bhubaneswar and subsequent No. 1077/Emg. Dt. 11.06.2025 of Collector, Keonjhar, applications in plain paper are invited from the eligible candidates with their past experience for engagement of temporary boat crews (Launch Driver & Boat Khalasi) with monthly consolidated remuneration of Rs. 13,900/- (Rupees Thirteen thousand nine hundred) only per person for Launch Driver and Rs. 12,600/- (Rupees twelve thousand six hundred) only per person for boat khalasi to operate power boats and Aluminium power boats at different Blocks of Anandapur Sub-Division or within the territorial jurisdiction of Keonjhar district for a period upto 30.11.2025 from the date of joining.

Eligibility and Conditions:

1. The engagement is purely temporary basis and terminable at any time without prior notice and assigning any reason thereof.
2. The engagement will be valid from the date of joining of the selected candidates till 30.11.2025.
3. The last date of submission of application through Regd. Post/ Speed Post/ By hand to the Sub Collector, Anandapur is 21.06.2025 (on working day).
4. The candidate must submit Self declaration that they will be responsible for their own in case of untoward/ unfortunate incident.
5. Selection will be made by the selection committee considering the experience of the candidate.
6. The age limit for the applicant should be between 18-59 years.
7. Candidates applying for the post of Temporary Launch Driver must possess minimum 2nd class Launch Driving certificates issued by proper authority.
8. Fresh candidates (without any prior work experience) applying for the post of Boat Khalasi on temporary basis must possess Crew Training completion certificate from Crew Training Institute and fresh candidates applying for the post of Launch driver must possess 2nd class Launch driving certificate from Director of Ports & Inland Water Transport, Odisha.
9. Candidates having prior work experience with SPEO in the same post as applied for shall be given preference over others.
10. The candidates for both the posts will have to pass swimming test in river/ canal or any water body for a distance of 200 mts in 20 minutes. Assistance of Local Fire Officer/ Assistant Fire Officer must be taken to ensure safety measures during such tests.
11. The incumbents engaged to such posts above are not eligible to get any TA, DA conveyance or any other allowance.
12. The authority shall not be liable for any delay or loss of application in transit at any stage of the test.

13. The undersigned reserves right to accept/ reject any or all the applications without assigning any reason thereof.




