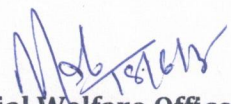

Sealed Tenders in the prescribed form are invited from the intending registered Transport Contractors/Agents having valid license to be engaged for transportation of Ragi in Ragi Laddu Programme under DMF funds from TDCCOL, Dhenkikote godown to Cleaning centers (Champua Vill:Tuntuna , Jhumpura Vill:Barakhandia , Sadar-Jamuhota, Banspal Vill:Talajagar , Hatadihi Vill:Hadagada, and Harichandanpur) and from cleaning centers to all Ragi Mix unit points of Keonjhar District within the maximum ceiling price of **Rs. 150/- per Qntl. [transporting/labour/loading and unloading cost etc.]** for the year 2025-26 as per the prescribed terms and conditions. TERMS AND CONDITIONS OF THE TENDER

1. The Tenderer/bidder shall carefully go through all the terms and conditions of the tender documents and submit the tender paper correctly and in complete form. The tender paper should be filled up properly and legibly without any correction/overwriting and must be a typed copy/computer typed copy. No opportunity shall be given to the tenderer/bidder to rectify or amend any defect detected at the time of scrutiny. The rates should be written both in words and in figures in the tender paper. The rate quoted should be final and the tenderer/bidder shall not be allowed to change the same under any circumstances and it should be valid for the year 2025-26.
2. "No individual, company, firm, corporation shall participate in the tender process unless it obtains or possess valid Agent's license owned by the tenderer under Orissa Motor Vehicle (Licensing of Agents) Carriage by Road Act, 2007 & Carriage by Road Rules, 2011 for Keonjhar District.
3. The successful tenderer shall be required to lift Ragi from TDCCOL, Dhenkikote to Cleaning centers (Champua Vill:Tuntuna , Jhumpura Vill:Barakhandia , Sadar-Jamuhota, Banspal Vill:Talajagar , Hatadihi Vill:Hadagada, and Harichandanpur) and transport the same from Cleaning centers to all SHGs making Ragi Laddu (TIIR Units) under Ragi Laddu Scheme of the Keonjhar district as per the order of the DSWO, Keonjhar within the specified period.
4. It is the responsibility of the transporting agent to lift the Ragi on proper weightment and deliver the same to the SHGs of Keonjhar district on proper weightment. In no circumstances short supply or delivery shall be made by the agent to the SHGs. The weighing machine shall be taken by the transporting agent along with the vehicle. The agent will be held responsible for the shortage and damage noticed if any during transit and delivery. The quality and quantity of Ragi being transported may be inspected by the Govt. officials authorized by Collector/DSWO during transit and also at the delivery points. There shall not be any change both in quality and quantity of Ragi during transportation by the transporting agent and for any shortcomings in this front the transporting agent shall be responsible and this shall be treated as misappropriation by the transporting agent. If any misappropriation is noticed during inspection or otherwise, a penalty shall be levied which should be equivalent to 10 times of the cost of misappropriated Ragi apart from initiating criminal cases.

5. The tenderer/bidder should submit the following documents along with the tender paper. Document check list absence of any document/paper, the tender form will be liable for rejection by the Dist- Tender Committee. The tenderers/bidders are required to come with all the original documents for verification by the Committee at the time of opening the tender, if necessary. Earnest Money of **Rs. 50,000/- (Rupees fifty thousand)** only for transportation in shape of NSC/Term Deposit duly pledged in favour of District Social Welfare Officer, Keonjhar, shall be furnished along with the tender. Tender without Earnest Money shall be liable for rejection. Cash/Cheque shall not be accepted. No request for transfer or any previous deposit or adjustment of earnest money for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejections of the tender paper. No tenderer/bidder shall be allowed to withdraw his tender/ Earnest Money Deposit until the tender is finalized. In case the successful tenderer/bidder refuses for agreement for Transporting Agent after acceptance of his tender the Earnest Money Deposited by him shall be liable for forfeiture. The E.M.D of the unsuccessful tenderer/bidder shall be refunded after finalization of the tender where as the E.M.D of the successful tenderer/bidder shall be kept as Security Deposit and will be released after successful completion of contract period, settlement of payment thereof and audit of such account and after obtaining the audit report.

The Collector/DSWO shall not liable for payment of any interest on the Security Deposit or any depreciation thereof. The breach of any terms and conditions as per agreement and failure/unwillingness to undertake transportation work by the selected transporter/ tenderer/bidder within the time limit after acceptance of his tender may lead to forfeiture of E.M.D. The selected transporting agent shall be black listed for any other Govt. Tender if he fails to perform the duties as per agreement in timely, regular supply of food grains on proper weighment.

- VIII. List of trucks owned/leased by the tenderer with up to date documents (Xerox Copy duly attested) shall be furnished along with the tender documents. The tenderer **should have minimum three owned trucks/transporting vehicle for transportation for whole district.**
- X. The tenderer should file an affidavit executed either from the Executive Magistrate or from the Notary in support of non-involvement in criminal activities/ records.
- XI. The tender papers should be self-attested by the tenderer/bidder
- X. Maximum ceiling price for transportation is **Rs. 150/- (Rupees One hundred fifty) only** per quintal irrespective of distance.
6. The successful tenderer shall be required to furnish a minimum Bank guarantee for **Rs.5,00,000/- (Rupees five lakh) only** for whole district the period of contract from the date of agreement or for such amount as would be required by Collector, Keonjhar.
7. The successful tenderer shall have to execute an agreement as per the terms and conditions mentioned in the specified agreement formant within seven days of intimation of acceptance of his tender.
8. Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of the stock to whom it concerned and as per the approved rate incorporated in the agreement.
