### Terms and Conditions:

- Cost of Tender Paper:** The tender papers (including Tender call Notice, Approved Tender Schedule, BOQ & DTCN) will be available in the official web site (<http://kendujhar,odisha,gov.in>) from 05.08.2025 to 20.08.2025 and can be downloaded from web site.
- Bids shall be received by this Agency on or before 20/08/2025 through Registered Post/ Speed Post only.** The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same. **The Bidders must super scribe the Sl. No of the project and Name of the work on the sealed envelope.**
- The Bid will be opened on Dt 22/08/2025 at 11.00 A.M.** in the office of the undersigned in the presence of the members of the Tender/ Purchase Committee and the bidders or their authorized representative. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.
- Documents to be attached:-** The following document should be furnished with the tender papers, failing which the tender will be liable for rejection.
  - The tender paper cost shall be deposited in shape of demand draft payable at any Nationalized bank within the jurisdiction of Anandapur sub division of Keonjhar District.
  - The Bidders shall submit the requisite EMD @1% of the Tender amount in shape of Fixed deposit/Term deposit duly pledged in favour of the BDO, Hatadihi, as per Govt. guidelines.**
  - Self attested copy of Contractor registration certificate

- d) Self attested copy of valid GSTIN clearance certificate and PAN card
- e) Self attested copy of Caste Certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
- f) Bidders shall submit original affidavit regarding authenticity of their documents attached with the tender papers.
- g) Bidder shall submit the Tender document ( DTCN & BOQ) duly signed.
- h) As per codal provision works more than Rs.50.00lakhs should be in double cover mode (as per letter no-01/WR, Dated-01.01.2019 i.e cover-I contains (Technical Bid), Cover-II contains (Financial Bid) to be fill up separately indicating therein as "Cover-I & Cover-II" respectively and finally put together in one cover. The Cover-II of the bidder will be opened, if the bidder qualified in technical bid i.e cover-I. 1<sup>st</sup> Cover (Technical Bid) should contain requisite tender paper cost, EMD,GSTN, PAN, Contractor's RC, Affidavit, with the Tender in original and any other document as per DTCN (in PDF format). 2<sup>nd</sup> Cover (Financial Bid) should contain Bill of quantities (BOQ) & additional performance security (if applicable).

5. Checklist is to be duly filled in.

6. **Engineer Contractors desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year.** The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.

7. The required ISD Money @1% of the Agreement value to be deposited in shape of Fixed Deposit/Term deposit duly pledged in favour of the BDO, Hatadihi during drawal of Agreement.

8. **Additional performance Security Deposit:**

The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-14459/Dated 20-09-2018, Govt of Odisha, Works Department). As per office memorandum No 5992/Dt 27-04-2021 of Works Deptt. Govt of Odisha modification to APS will be followed as detailed below:-



9. Conditional tender will summarily be rejected.

10. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

11. If the rate quoted by the bidder is more than (14.99% less) of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.






