NOTIFICATION

Whereas the unauthorized parking of all goods carrying vehicles on main carriage way of NH 20, NH 49, NH 220, NH 520 & NH 720 and other express ways creates road hindering free movement of essential vehicles and carrying possibilities of road accident.

Keeping in view of the safety and security of the general public, I Sri Vishal Singh, IAS, Collector & District Magistrate-cum-Chairman, RTA, Keonjhar in exercise of powers conferred on me 115,116,117 of MV Act,1988 to be read with rule 63 & 93 of OMV Rules,1993 do hereby restrict unauthorized parking of all goods carriers on main carriage way of **NH 20** (from Ramachandrapur- Rimuli-Champua), **NH 49** from (Turumunga to Binjabahal), **NH 520** (from Rimuli to Rugudihi) **NH 220** (from Dhenkikote- Patna-Saharpada), **NH 720** (from Naranpur to Brahmanipal) and **Expressway-II** (from Ranasalaghati, Joda-Bamebari-Palaspanga) for a period of one month.

This restriction will come into force **w.e.f 25.09.2025 to 24.10.2025**.

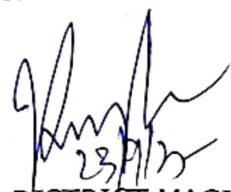

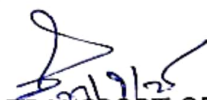

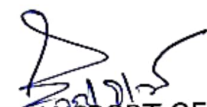
