**3. Quality requirements for Security Personnel**

All Security Guards provided by the Agency should be smart, trained and should have requisite skill in the following aspects:

1. Dressed in proper uniform, sincere, well behaved & disciplined.
2. Able to read, write & speak Oriya. Working knowledge of Hindi & English.
3. Able to keep proper watch & ward.
4. Knowledge of fire extinguisher operation.
5. Able to ride motor bike.
6. The Person engaged in the Security Guard with Lathi or the Supervisor should not be repeated in another shift of a day and consecutive two shifts.
7. Each guard should be aware of their duties & responsibilities during the duty hours.

**5. CCTV:**

CCTV cameras are to be installed at different locations at District Level Subhadra Shakti Mela ground to watch the theft and any unlawful activities. 10 nos. of CCTV cameras are to be installed in the mela ground. The monitor(screen) of the CCTV needs to be placed in the control room in the mela ground. The DVR need to be installed for back up the data. For smooth monitoring of the CCTV one person need to be deployed throughout the mela period.
