1. The bidders have to submit their tenders in separate sealed covers (**i.e. Cover “A”- Technical Bid & Cover “B”- Financial Bid**). Both the covers should be placed in a sealed cover and the cover must be super-scribed as “Tender for supply of Reagents & consumables required & compatibility For **Fully Automated 7 Part Differential Hematology Analyzer Machine, Make: Transasia (Erba Mannheim) Model: H 7100** for Dharanidhar Medical College & Hospital, Keonjhar.

The Following documents of the bidders are required to enclose in **Cover “A” (Technical Bid)** as well as the terms & conditions he/she should fulfill/ensure/abide by are as follows:

- i) Checklist with details of the documents as per **“Annexure – I”**. The documents should duly be paged and serially be arranged. They should also be securely tied and bound. 
- i) The Financial Bid in the prescribed format as per **(Annexure-II)**. No other document should be enclosed in the Bid in cover-B.

- iii) The procurement order will be send by e-mail only and all correspondence regarding procurement process.
- iv) Tenders' documents should be typewritten or computerized, failing which the bidders will be considered ineligible to participate in the bidding process. No further correction/modification/alteration shall be allowed under any circumstances.
