Expression of Interest for Empanelment of X-Ray Services for Intensified TB Elimination Campaign in Keonjhar District under National Tuberculosis Elimination Programme.

Interested Agency/vendors with the following prerequisites are requested to submit "Expression of Interest for Empanelment to provide X-Ray Services for Intensified TB Elimination Campaign in Keonjhar District. The Intensified TB Elimination Programme is an annual campaign to detect & treat TB for its elimination. This ambitious programme is part of the National Tuberculosis Elimination Programme (NTEP), which focuses on strengthening diagnostics, implementing innovative policies, and engaging private sector and other partners. Chest X-Rays (CXRs) play a crucial role in the elimination of Tuberculosis (TB) by serving as a primary screening and triage tool. It helps in prioritize those who need further testing, like NAAT for drug-susceptible testing. Early detection of TB, enabled by CXRs, is crucial for preventing the spread of the disease and improving patient outcomes. While access to high-quality CXRs is limited in some settings, efforts are underway to improve accessibility, including the use of Static, Mobile & Hand-Held X-ray with the support of Partners.

- **Eligibility Criteria:**

- The bidder must be an Agency/vendors having valid GST registration/ a Clinical Establishment registered under Clinical Establishment Act.
- The bidder must have a local office in Odisha having valid GST registration with local contact person's address and telephone no.
- The bidder must have minimum one or more Static X-Ray Unit/or more Portable x-rays/or more Hand-Held x-ray machine/s.
- Valid AERB certificate available in case the Agency/Firms/Clinical Establishments have Static X-ray/Portable X-ray machine/s.
- In case of Static X-Ray Center, the Agency/Firms/Clinical Establishments must have the Center/s in the Keonjhar district.
- X-ray machines must be registered with the relevant regulatory bodies in India, as mandated by the Medical Device Rules, 2017.
- The bidder must have past experience in managing or implementing Govt. Health Projects successfully at least 01 year or more. Work order & end user certificate should submit with bid document.

- **In case of Digital Hand – Held X-Ray Machine following certification are required:**

- OEM authorization if applied Firm/Agency is not manufacturers.
- The quoted model must be registered under CDSCO and submit the license to manufacture for sale or for distribution of the medical device.
- It should be AERB Type Approved.
- ISO 13485 certificate issued from a notified body or ICMED 13485 (with or without plus) certificate issued from certification bodies accredited by NABCB or ISO 13485 certificate issued from certification bodies accredited by NABCB/Nationally Recognized Accreditation Board under IAF MLA.
- The model also has Electrical Safety Standards: IEC 60601
- Relevant Certification for AI generated report.
- X-Ray shall be conducted by qualified Radiographer.
- Radiologist either available physically or connected remotely to issue report with signature & seal.
- The bidder should submit the required **Tender Cost Money of Rs.2000/-** (Rupees two thousand) only (Non-refundable) should be submitted in the shape of a Demand Draft only in favor of **ZSS NON NRHM Fund Keonjhar** from any Nationalized/Scheduled Bank payable at Keonjhar.
- The bidder should submit **Earnest Money Deposit (EMD) of Rs. 50,000/-** (Rupees fifty thousand) Only (Refundable to un-successful bidder after tender process complete). The EMD should be submitted in the shape of a Demand Draft only in favor of **ZSS NON NRHM Fund Keonjhar** from any Nationalized / Scheduled Bank payable at Keonjhar.

- The bidders must submit the Technical & Financial Bid separately in the sealed envelope and both the Technical & Financial Bid (Annexure-D) envelopes must be kept another envelopes (Outer). The Outer envelopes must be superscripted on the top of the envelopes "Expression of interest for Empanelment of X-ray service"

- **Modalities of Implementation & Price per X-ray:**

- The Agencies/Firms/Clinical Establishments shall reach out to vulnerable Population for X-ray at nearest CHC/PHC/UPHC/SC) or mobilize the cases to attend Static X-ray Center/s.
- The health administration shall provide space at health facility for organizing camp for X-ray (in case of hand-held x-ray device).
- The health administration shall also share camp schedule with dates to the agency (for hand-held & mobile x-rays) for smooth management of the programme.
- There is no provision of transportation cost in any form to mobilize eligible cases to centers for x-rays.
- There is provision @ Rs. 250/- shall be paid per x-ray which includes Manpower Cost, Machine Cost, GST and other charges, if any.
- Agency shall not claim more than @ Rs. 250 per case by mentioning any reason there off.
- The agency shall share x-ray films & report in hard copy signed duly by Radiologist in case of Static & mobile center and AI generated report for hand-held x-ray.
- The x-ray wise details of the bills and other related documents as desired by the authority shall be submitted to the district office for release of payment on monthly basis. The payment shall be released within 10 days of submission of bills & related documents if same is in order/as per the requirement.

- **Period for Empanelment:**

- The empanelment would be for the period of minimum 02 years (Co-terminus with financial years) which can be extended for another one year, if performed satisfactorily as per the expectation of appropriate authority.

- **Other Conditions:**

- Eligible bidders should submit their tender documents to O/O – CDM & PHO, Keonjhar, At/Po/Dist. – Keonjhar - 758001, through Speed Post/Regd. Post/Courier on or before 05.00 P.M on Dt. 05/01/2026.
- Any tender documents received after the due date & time will be rejected and returned to the sender unopened.
- The bids will be opened on dt.: 06/01/2026 at 11.00 AM at office of the undersigned and empanelment will be finalized.
- The bidders/ representative will come with the authorization letter to attend the tender meeting
- Violating any terms and conditions of the tender will be liable for blacklisted and the authority has rights to disqualify and debarred the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter.
- Tender documents should be typewritten or computerized with signature of bidder, failing which the bidders will be ineligible for consideration. No further correction will be allowed.
- All bid documents should be page mark.
- All legal disputes are subject to the jurisdiction of Court of District Judge Keonjhar only.
- The undersigned has the right to reject/modify/cancel the entire bid without assigning reason thereof.
