The proof of registration from the appropriate authority shall be enclosed along with the Bid. The successful bidder who has not registered under state Government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

4. ii) Only the successful Bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish as per amended vide O.M. No.14459 dt.20.09.2018 of Works Deptt. Govt. of Odisha has been modified with O.M. No.173 Dt.03.01.2026 & O.M. No.632 dtd. 09.01.2026 of Works Dept., Govt. of Odisha as Additional Performance Security in shape of Term Deposit Receipt pledged in favour of the Divisional Forest Officer, Keonjhar Division, Keonjhar / Bank Guarantee in favour of the Divisional Forest Officer, Keonjhar Division from any nationalised schedule bank in India counter guaranteed by its local branch within seven days, otherwise the bid shall be cancelled and further proceeding for blacklisting shall be initiated against bidder.

5. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 Hours of 28.01.2026 to 17.00 Hours of 04.02.2026.

6. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II and Class-III.**

7. Bids shall be received only **"On-line"** on or before **17.00 Hours of 04.02.2026.**


