
NOTIFICATION

WHEREAS the Additional District Magistrate, Keonjhar has intimated that, the AHSC Exam. (Class-x),2026 & +2 Council of Higher Secondary Examination,2026 and will be commenced from 19.02.2026 to 02.03.2026 & from 18.02.2026 to 28.03.2026 respectively in the Keonjhar District.

2. AND WHEREAS the question papers shall be dispatched from Nodal Centres to different Examination Centres during morning time on the date of examination. It may cause dislocation in conducting examination if heavy transport vehicles (both loaded/ empty) obstruct en-route.

AND WHEREAS the Additional District Magistrate-, Keonjhar in his letter no. 800/DEV dated 10.02.2026 has requested for discontinuance movement of heavy transport vehicles (both loaded/ empty) on the date of the +2 Council of Higher Secondary Examination,2026 i.e. from 18.02.2026 to 28.03.2026 and the AHSC Exam. (Class-x),2026 from 19.02.2026 to 02.03.2026 from 05.00 AM to 10.00 AM for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees and Nodal Officers.

Now, therefore, in exercise of powers conferred on me by section 115 of Motor Vehicle Act, 1988, I, Shri Vishal Singh, IAS, District Magistrate and Collector-cum-Chairman, Regional Transport Authority, Keonjhar, do hereby ordered to restrict movement of heavy transport vehicles carrying (both loaded/ empty) passing through (1). Suakati, Banspal to Keonjhar Town (2) Bileipada to Barbil MPL of Joda Block, (3) Bileipada to Bamebari, Basantpur of Joda Block in the district of Keonjhar for the period from 05.00 AM to 10.00 AM from 18.02.2026 to 28.03.2026 and from 19.02.2026 to 02.03.2026 for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees and Nodal Officers.
