1. The Tender form along with terms and conditions can be obtained from the office of the Child Development Project Officer, Telkoi by paying Rs.100.00 (Rupees One hundred) only during office hour from date **22.04.2026 to 28.04.2026**.
2. The paintings will be done as per specification given in Tender from Part II. The colour of paintings will be made exactly as prototype. (For details one may contact office).
3. The sealed quotations shall be received by the undersigned through the Registered Post with A.D. or by hand from dt.**22.04.2026 to 28.04.2026**. (7.00 A.M. to 1.00 P.M.) on working days and the same will be opened on **29.04.2026** at 10.30 A.M. in the Office Chamber of the BDO, Telkoi in presence of the Members of Tender Committee and the Quotationers or their authorized agents/ representatives.
4. No Quotation will be entertained after the stipulated date and time.
5. The Quotationers have to quote single rate of paintings and the price quoted must be inclusive of all taxes, transporting cost and other incidental charges if any. The rate quoted should be final and the quotation shall not be allowed to change the same in any circumstances.
6. The Quotationers shall deposit the Security Money amounting to Rs.5000/- (Rupee five thousand) only in the Office of the undersigned and attach the original Money Receipt with the Quotation. The Security Money of unsuccessful Quotationers will be refunded after finalization of the Tender Process on proper application. The Security Money of the successful Quotationers will be refunded after completion of paintings works.
7. The Quotation once submitted will not be returned back or exchanged.
8. Non-fulfillment of the aforesaid terms and Conditions will lead to non-acceptance of Quotation.
9. The successful Quotationers shall complete painting works within two months from the date of receipt of the order, failing which the order will be canceled and simultaneously the Security Money will be forfeited.

11. Any Firm black listed by Central/State Government/ Board/ Corporation/ Autonomous body under Administrative control of Central/State Government etc. will not be entertained by the Tender Committee.
11. Payment will be made by the CDPO, Telkoi after completion of paintings works. The Agency will have to submit the completion report in prescribed Performa with the Seal and signature of AWW. The photo copy (soft copy) of painting will have to submit in the office of the CDPO, Telkoi before claiming for payment. (The photo should be taken in presence of AWW concerned. The completion report should be submitted after completion of painting in each GP.
12. The appearance of the paintings will be exactly as prototype. However, the Asian oil paint should be used for painting work.
13. The approved Quotationer is required to submit the copy of First Page of Bank Account Pass Book along with canceled cheque for easy transaction of payment for the painting works done by the approved quotationers.
14. The CDPO, Telkoi reserves the right to cancel any or all the quotations without assigning any reasons thereof and may be accept the lowest rate quoted by the any Quotationer considering the quality of paintings.
15. The Quotations will be in three parts i.e. Technical Bid (Part-I), Financial Bid (Part-II) & Declaration (Part-III).
